- \$19 million verdict against Stonebridge Life Insurance Company for its unlawful medical necessity peer reviews. (*Nickerson v. Stonebridge Life Insurance Company*)
- \$3.7 million binding arbitration award against Travelers' Indemnity Company of Connecticut for its use of a policy provision that was found to violate California law. (*Mave Enterprises, Inc. v. Travelers Indemnity Company of Connecticut*)
